- To complete the registration process, please submit a filled/signed copy of this form along with the participant's passport copy and a short video of his/her performance. This should be submitted to the Information Desk on Level S1 or sent via email to burjumansrisingstars@gmail.com.
- Registrations are open from 11th August – 5th September 2019. Registrations will not be accepted after 10pm on 5th September 2019.
- Please ensure that a specific category is selected when filling out the form. Kindly note that the "Others" category does not have a definite scope. This category can involve elements of singing/dancing and any other talents as well.
- All participants should be UAE residents and studying in a school in the UAE.
- Performances should be of a maximum duration of 3 minutes.
- There is only one entry per person. If you enter with a group, you may not enter as an individual. All members of the group must be within the mentioned age group.
- The number of kids that can be auditioned on stage is limited due to time constraints, therefore, kids will be selected on a first come first served basis.
- For the auditions, semifinals and finals the participants will be selected by an independent panel of judges. The judges' decision will be final. For all other aspects, BurJuman Management's decisions will be final and binding. There will be 3 winners in each category – Singing/Dancing/Others. "Others" will be considered as one category.
- For any groups that will participate, there will be only one representative's name mentioned on the National Bonds certificate. The prize should be shared between all participants of the group.
- Parents/Guardians of children that are selected to perform at BurJuman's Rising Stars will be responsible for all expenses incurred relating to the competition including transportation, meals, costumes, makeup and so forth. All acts, costumes, and props MUST be appropriate for all audiences.
- Parents/Guardians of children that are selected to perform at BurJuman's Rising Stars will be responsible for all the materials needed for the competition including music (on USB), props, instruments etc.
- It will be parents/guardians responsibility to take care of their kids during the Show and BurJuman will not be responsible for any loss of personal belongings.
